#### I. Definitions

#### I/1. Provider

# II. License agreement and Use Agreement

The conclusion of the License Agreement and Usage Agreement shall be done electronically in the clear referral behavior of the user and visitor, when the Client accepts the GTC (Terms of Use) without registration.

The Fortune Cookie (4tunecoo.com) performs the ordered service for the Client.

### III. Service

The service is available without prior registration and free. The Service Provider issues an invoice based on the data provided by the Principal and sends a fortune cookie message to the Recipient, or a photo of a personal message or an access link that you can forward to the recipient in any way (for example: copied Messenger, Skype,Viber ....etc in message) The copy of the Fortune cookie, personal message link will immediately appear on our website. The fortune cookie messages are left to fate, luckily selected by our artificial intelligence from our database, this is what the recipient receives. Personal messages will not be censored so for their content the Fortune Cookie (4tunecoo.com) takes no responsibility. If this occurs, the content will be deleted upon request and the sender will be excluded from our system queue.

#### IV. Customer Data Service

It is the Client's responsibility to provide the recipient's recipient name, own name, email address on the Fortune Cookie website (4tunecoo.com). In addition, choose whether you want to send a personal message (written by him/her text of up to 120 characters) or a lucky message (text entrusted to artificial intelligence). After uploading your own photo, you can place your own text on it, the text can be edited. When choosing your personal message type (love, birthday, holiday, wedding, other) the wallpaper will change according to your choice according to the patterns presented on our website. We do not investigate the copyright of your own uploaded photo, so there are only those pictures that are not protected by copyright may be uploaded to our system.
